10:00 AM Virtual Meet-N-Greet with Sharon Thibodeau, Central Ohio Regional Liaison from Ohio Department of Mental Health and Addiction Services

Commissioners met with Sharon Thibodeau, Central Ohio Regional Liaison, from the Ohio Department of Mental Health and Addiction Services, in a virtual meet-n-greet. Sharon introduced herself, explained her role as part of the Office of External Affairs and asked the Commissioners for the needs and concerns for Knox County, in regards to mental health and addiction services. She explained part of her position is to connect agencies, organizations, board members, and service providers to the individuals that need mental health and addiction services. She is reaching out to the counties in her territory and gathering information on what services are available, what programs are needed and possible funding options. Sharon reported she recently visited Knox County for the kick-off of the Behavioral Healthcare Partners (BHP) Mobile Crisis Unit and The Freedom Center's new facility. The following are highlights from the meet-n-greet discussion:

*Commissioner Bemiller stated she is excited to have the BHP Mobile Crisis Unit available in Knox County and it will enable individuals to have easier access to Mental Health and Addiction Services - She stated she has worked closely with Kay Spergel with Mental Health and Recovery for Licking and Knox Counties and with the local and state OneOhio Committees and challenging funding application process - Commissioner Bemiller encouraged Sharon to reach out to Kay Spergel, as she will be the representative for Knox County and Regional OneOhio Committees

*Commissioner Pursel stated the Freedom Center is an asset to the community, in hopes of room for expansion to grow - He inquired if there is any funds in the portfolio that helps with housing/rental assistance for mental or addictive behaviors of individuals and how to access these funds

*Sharon reported there is Landlord Mitigation Funds and Access to Wellness Funds available - interested agencies and organizations could contact the Mental Health and Recovery for Licking and Knox Counties agency or Behavioral Healthcare Partners (BHP) to inquire about the funds and the process to obtain funds - these funds are for rental/housing assistance for individuals transitioning from jail or in-patient facilities and help with rent/deposits, household items and/or job related expenses - Another option is for Case Managers/Jail Social Workers to access funds for basic needs of transitioning inmates

*Sharon thanked the Commissioners for their time, exchanged contact information and value the input of their concerns and needs for the Knox County community

10:30 AM Departmental Update - Knox County Sheriff

Commissioners met with Sheriff David Shaffer in a regular departmental update. He answered questions from the Commissioners and discussed the following items:

- *Executive Session to discuss Collective Bargaining Matters with Drew Espisito, Attorney from Clemans Nelson and Associates
- *Sheriff Shaffer reported the current jail census includes 14 females and 57 males for a total of 71 inmates 5 inmates are housed out of county for treatment, assessments, etc.
- *Jail Inspection was completed with 100% rating on 176 standards Healthcare Service was present during inspection to assist with medical portion of inspection Becky Newport did an excellent medical presentation
- *Sheriff Shaffer reported meetings continue for the transition/implementation of Right Stuff timekeeping/payroll software from PlanIT Scheduling software software does not offer all functionality that the department needs PlanIT software contract expires in February and it may be in the best interest to continue contract rather than transitioning to Right Stuff software
- *Sheriff Shaffer reported he met with the newly elected Sheriff and gave him all the required paperwork to start the hiring process nothing has been returned yet notified I.T. Department to set up county email account
- *Wrapping up administrative functions, closing accounts and charge cards for a smooth end of year transition creating instruction check-off list for setting up new accounts, credit cards, etc.
- *The Audit for the Evidence and Property Room will be completed the first week of December Outside individuals will be brought in for accountability/verification as 2 people must sign off on account will reconcile the fund to prepare for transfer of account holders
- *Staffing 2 deputies on light duty due to injuries down 1 Patrol Deputy fully staffed in Jail waiting for background checks on 2 potential hires have temporarily moved detectives to open spots until employees return to full duty and positions are filled
