#### 10:00 AM CDBG Public Hearing #1 for PY2025 Programs

Commissioners conducted the Knox County FY 2025 Public Hearing #1 for the Community Development Block Grant (CDBG). The following individuals were present for the hearing:

Jillian Flowers, Associate Planner from CDC of Ohio, Inc., distributed the agenda for the hearing and reviewed the following key points:

#### **Discuss National and State Objectives**

The Ohio Department of Development, Office of Community Development (OCD) administers numerous CDBG, HOME, and related grants for small non-entitlement communities throughout Ohio. All funds must be used to benefit low-to-moderate income persons or eliminate slum and blight. At least 51% of all grants must benefit low-to-moderate income persons.

#### **Amount of Funds Available**

Ohio estimates it will receive approximately \$105 million in federal PY 2025 funds. Of this amount, about \$45 million will be CDBG and \$27 million in HOME funds.

#### Grants Available to Knox County in PY 2025

Residential Public Infrastructure Grant (RPIG) - up to \$750,000 to fund large-scale water and sanitary sewer programs. Requires 1:1 match and specific rate structures.

Critical Infrastructure Grant - up to \$500,000 to undertake 1 critical project.

Economic Development Grant - up to \$500,000 to provide on-site or infrastructure improvements to a business that commits jobs for low-to-moderate income persons.

Target of Opportunity Grant is for projects that don't fit into a normal grant, but are a priority for the state - up to \$250,000.

#### **Application Dates**

The first round for CDBG Critical Infrastructure Grants is due on June 11, 2025.

All other applications are open-cycle beginning on July 1, 2025, until funds run out.

All programs have a 26-month grant period.

#### **Past Performance**

CDBG Community Development funds have recently completed storm sewer and culvert improvements in Pike, Brown, and Butler Townships and street improvements in Berlin Township. The County has also completed street, storm sewer, sidewalk, and park improvements in Danville and the Parrott Street Bridge. Knox County completed the Martinsburg Water Improvements, Danville Mickley/Richards Street Water Improvements, and the Knox County Courthouse ADA. Knox County is currently under contract to complete the Martinsburg Water Improvements Phase II Project and is looking to bid out the Danville Park Improvement Project sometime in the Summer of 2025.

#### **Second Public Hearing**

While this hearing discusses all of the programs available, the County is also required to hold a public hearing that is specific to each grant it applies for. The hearing will explain exactly what the County will include in each application and enable public comments.

The second public hearing for the PY 2025 CDBG Critical Infrastructure grant will be Tuesday, June 3, 2025, at 10:00 a.m.

Notice of all public hearings will be published in the Mount Vernon News and posted on the Knox County Public Notice website.

#### **Public Comment/Discussion**

Joel Stachler and Joe Mazzari reported the Village of Danville would like to apply for funds for a shovel ready water and sewer line infiltration project. The \$470,000 project would be 100% covered through the grant program. Commissioner Pursel asked if the Village of Danville has ever applied for Ohio Public Works Commission (OPWC) funds and if new water meters were installed in the village. Joe Mazzari stated they have applied for OPWC funds in the past but have not currently. Joe stated new meter installations are 75% complete along with mapping and camera work. Joe also discussed other projects in Danville that he would like to explore funding options for including neighborhood revitalizations, park restrooms and safety options for the bike trail crossing over Market Street.

Jillian Flowers stated based on new ACS Data, the Low to Moderate Income (LMI) areas include Martinsburg, Danville and Brinkhaven. Danville and Brinkhaven completed income surveys to verify LMI status. She reported the CDBG Allocation Program for PY 2026 is estimated to be \$156,000 (down from \$158,000). She also reported Brinkhaven is possibly working on submitting a funding application for 2026. Jillian stated there is ongoing conversations for projects for the Neighborhood Revitalization funds. ### RESOLUTION 2025-257--AUTHORIZING PARTICIPATION IN THE OHIO DEPARTMENT OF TRANSPORTATION (ODOT) ROAD SALT CONTRACTS AWARDED IN 2025.

WHEREAS, the Knox County Commissioners, Knox County (hereinafter referred to as the "Political Subdivision") hereby submits this written agreement to participate in the Ohio Department of Transportation's (ODOT) annual road salt bid in accordance with Ohio Revised Code 5513.01(B) and hereby agrees to all of the following terms and conditions in its participation of the ODOT road salt contract:

- a. The Political Subdivision hereby agrees to be bound by all terms and conditions established by ODOT in the road salt contract and acknowledges that upon award of the contract by the Director of ODOT it shall be bound by all such terms and conditions included in the contract; and
- b. The Political Subdivision hereby acknowledges that upon the Director of ODOT's signing of the road salt contract, it shall effectively form a contract between the awarded salt supplier and the Political Subdivision; and
- c. The Political Subdivision agrees to be solely responsible for resolving all claims or disputes arising out of its participation in the ODOT road salt contract and agrees that each party hereto shall be responsible for liability associated with that party's own errors, actions, and failures to act; and
- d. The Political Subdivision's electronic order for Sodium Chloride (Road Salt) will be in the amount 5,000 tons, the Political Subdivision agrees to purchase from its awarded salt supplier at the delivered bid price per ton awarded by the Director of ODOT; and
- e. The Political Subdivision hereby agrees to purchase a minimum of 85% of its electronically submitted salt quantities from its awarded salt supplier during the contract's effective period; and
- f. The Political Subdivision hereby agrees to place orders with and directly pay the awarded salt supplier on a net 30 basis for all road salt it receives pursuant to ODOT salt contract; and
- g. The Political Subdivision acknowledges that should it wish to rescind this participation agreement it will do so by written, emailed request by no later than Friday, May 2, 2025, by 5:00 p.m. The written, emailed request to rescind this participation agreement must be received by the ODOT Office of Contract Sales, Purchasing Section email: Contracts.Purchasing@dot.ohio.gov by the deadline. The Department, upon receipt, will respond that it has received the request and that it has effectively removed the Political Subdivision's participation request. Furthermore, it is the sole responsibility of the Political Subdivision to ensure ODOT has received this participation agreement as well as the receipt of any request to rescind this participation agreement. The Department shall not be held responsible or liable for failure to receive a Political Subdivision's participation agreement and/or a Political Subdivision's request to rescind its participation agreement.

NOW, THEREFORE, be it ordained by the following authorized person(s) that this participation agreement for the ODOT road salt contract is hereby approved, funding has been authorized, and the Political Subdivision agrees to the above terms and conditions regarding participation on the ODOT salt contract: Commissioner Keesee, Commissioner Lester and Commissioner Pursel
